TERMS OF USE BELOW MUST BE READ BEFORE USING THIS SITE. USE OF THIS SITE SHOWS ACCEPTANCE AND COMPLIANCE WITH THESE TERMS AND CONDITIONS BELOW.

The site www.bikintour.com ("Site") is managed by bikintour ("us"). By accessing and / or using the Site, you acknowledge that you have read and understood, and agree to be bound by the Terms of Use set forth below and other terms and conditions in relation to the Site, including but not limited to confidentiality and FAQs, which are an integral part of the Terms of Use ("Terms"). You must be at least eighteen(18) years to use this Site.

Please note that we may change, modify, add and delete these Terms at any time without prior notice. Terms must be read periodically. By continuing to use this Site after such changes to the Terms, visitors, users or Registered Users ("you" or "users") agree and agree to the changes. If you use one of our other services, your use is based on compliance and acceptance of the terms and conditions that apply to that service .

1. SCOPE OF OUR SERVICES

Through the Site, bikintour provides an *online* platform so you can browse various types of speedboats (fleet), and other transportation, temporary accommodation and lodging (as applicable), attractions, travel packages, and make reservations, reservations and / or purchases ("Services "). Users can make reservations for services provided by hotels, speedboats (fleets), other transport operators, tour operators, travel agents, and / or other service providers who work with bikintour ("Vendor") on the Site. By placing the order through the Site, you will be able to order and / or buy tickets Speedboat (fleet), and other transportation, hotel rooms, tour attractions, package trip travel, or service other on trusted us. We will giveConfirm order or purchase via email confirmation. We reserve the right to reject bookings as set forth below.

1. Although we will use our expertise with care in conducting services, we do not verify, and do not guarantee, that all information provided is accurate, complete, correct or up-to-date available, and we are

not responsible for any errors (including placement errors and typing), interruptions (both temporary and / or partial, damage, repair or improvement to the site or vice versa), inaccurate, misleading or false information or information that is not conveyed. This includes any information displayed on our Site or other platforms relating to the type of speedboat (fleet), seat layout, distance between seats, and the availability of other facilities on the speedboat (fleet).

2. Changes in market conditions or circumstances that occur can cause changes in a short time, which causes information to be inaccurate or invalid. In the event of a problem, customer service can strive to help you and fulfill your requests.
3. This site makes no representations and cannot be considered as making recommendations or suggestions on the level of service quality or ratings of Vendors registered on the Site. We hereby declare the denial of claims, losses or liabilities relating to the quality or status of Vendors that exist and are registered on the Site (which provides speedboat services (fleets), and other transportation operators, hotels, managers of attractions, other services). In case the order is rejected or canceled by bikintour and payment has been made, bikintour will reimburse the amount charged less administration fees. 10. PAYMENT WITH CREDIT CARD & FRAUD

1. For payment of orders placed through this Site, your credit card will be charged by bikintour for the full price at the time of booking and confirmation of the order (any refunds that may be given will depend on the existing reservation conditions).
